2. OBJECTS

- 01. To improve mother tongue and higher knowledge among the world wide tamilians
- 02. To organize / integrate to world tamilians and propaganda education of Tamil literature.
- 03. To improve cordial relation among the people from various area through arts and cultural activities (through media).
- 04. Exchange of Arts and cultural concept among the existing people.
- 05. The Organization has no political color However the organization protects rights and integrity among the people and also establish concept of given and take policy not only as great citizens in the existing country and make there integrity among different cultural society and establish substantively in Economic development and Human Rights also.
- 06. To establish a separate museum to preserve Tamil arts , issue articles / books.
- 07. without distinction of Religions, to propaganda concept of equal and concept of non secularisms
- 08. To organize seminars conferences world wide about Tamil literature, arts history, Thirukkual.
- 09. To conduct religious rituals prayer for the Tamil and also enforce it.
- 10. to Introduce and encourage traditional sports of tamilians for their regions

- 11. To sanction awards to tamilians belonging the various countries for their innovative activities and achievement through their research and identify the tamilians in different areas and also improving Tamil Culture among themselves
- 12. To take appropriate action to declare the Tamil month Thai as hereditary month by the local government of concern countries in which the tamilians have been repatriated.
- 13. On Commemorating the Tamil heritage Month Thai and the Tamil language, the organization can conduct Arts Cultural programme, procession, competition of Tamil speech and poetry among the children and also enforce the same.
- 14. On contacting the UNSCO, the organization and also cooperating the world integration through this efforts the Organization shall attempt to enroll as member of United Nationation's Organization.
- 15. To publish journals of Tamils especially to achieve above mentioned targets.
- 16. To establish Central Administrative wing for our organization.

3. Flag and Symbol (logo)

01. The Organization holds world wide flag royal she yellow the back screen and also presence of palm script, lotus and sun which are in triangle with in the circle around the circle shows" INTERNATIONAL MOVEMENT FOR TAMIL CULTURE ESTD 1974"But it is lack in the Flag of world tamilians 02. Royal blue refers sky and marine (sea) yellow is auspicious holy, bright palm script refers intellectual, lotus always refers natural wonders and the sun also signifies ancient tradition of Tamil

4. MEMBERSHIP

- 01. Tamilians of the world, who attains 18 years, may be enrolled as a member without gender bios
- 02. If the individual wants to become member the concern may submit the prescribed form of the world Tamil Cultural organization to the secretary of the concern region/nation. Whether it is accepted or not is decided by the respective executive committee of branch and shall be also forwarded to the Secretary of the World.

- 03. The member should pay first annual subscription (prescribed endowment-fees) of the respective year.
- 04. If any one who fails to pay annual endowment-fees, he can be disqualified from his membership.
- 05. The President has been empowered to disqualify any individual with the approval of the respective branch.
- 06. Any member can approach the head of the branch and the Head of the world through written communication.
- 07. Life Members are also enrolled through the prescribed application forms.

5. SELECTION PROCEDURE FOR EXECUTIVE COUNCIL MEMBERS.

- 01. The Selection of the World President, the World Secretary, the World Secretary (Finance) shall be done under confidential Voting System..
 - (A). For above Mentioned designations, willing-petitions shall be submitted to the World secretary through the branch of respective country with proper representation and proper recommendation within 15 days before. If one or more petitions are obtained, the selection process shall be done under confidential. This election shall be done by the head of the Guardian of this organization.
- 02. Five members may participate from the registered branch of each country. More than Five members may also participate as representatives of the conference. In the General Body Meetings, five members belongs to the registered branch of each country can be empowered to give right of votes
- 03. One month before, the branch of each country should forward the details of the representatives who will participate in the conference to the World Secretary.
- 04. Total number of the Administrative Members is 21
- 05. The Enforcement Committee consists of 9.and also the Presidents of the six continents, World President, World Secretary, and World Secretary (Finance)
- 06. Age Members of the Administrative Council members should be below 75 Years.

6. IMTC PRESIDENT

- O1. Selection/Election to the post of the World President can be done once in three years. The Member who should have 5 years experience in the post of the executive member in a registered branch of the country.
- 02. The President presides over all the meetings including conferences, Training programmes and all the functions of the organization.
- 03. He has empowered to sign all the Legal documents.
- $04. \quad The World President can jointly sign the same with the World Secretary.$
- 05. The President shall be represented any three invitations and various functions. with his consent, any executive member may be assigned the same
- 06. After the enforcement of new yabbu rules, the World President may also hold the post only in two terms.
- 07. The President shall appoint various Head of the Departments.

7. IMTC SECRETARY

- 01. The Executive Member Who should have 5years experiences in any registered branch shall be elected by the General Body.
- 02. The World Secretary shall conduct the General Body Meetings with ascent of the President.
- 03. On behalf of the World President he shall represent him self.
- 04. He can make world wide contacts
- O5 After the enforcement of new yabbu rules, the World Secretary may also hold the post only in two terms.
- 06. The World president shall be empowered to conduct and co-ordinate world wide conferences also.
- 07. He shall be empowered to handle the financial management with the approval of the World President and the World Secretary (Finance)
- 08. Conducting and enforcing the resolution of the General Body meetings are main duties of the World secretary. In this regard the World Secretary (Finance) also allocates financial sources.

8.IMTC SECRETARY (FINANCE)

01. The Executive Member who should have 5years experiences in any registered branch shall be elected as the World secretary (Finance)

- 02. He is a right person to handle all financial transaction of the Head-Quarters with proper accounts and also involve various fund raising aspects on behalf of the organization.
- 03. On getting ascents from the World-President and the World Secretary, he can handle the bank accounts of the Head-Quarters if they are in various countries the Written approval should get from them.
- 04. He has right to represent him-self on behalf of the World President.
- 05. He can handle financial management under leadership of the world secretary regarding the conference.
- 06. Regarding Endowment-Funds, he can handle all the receipts and payments among the branches.
- 07. He can retain \$100 for incidental expenses

9. IMTC VICE-PRESIDENTS

- 01. Three World Vice Presidents who have already worked as members of the executive committee of any branch shall be elected by the General body once in a three years.
- 02. On behalf of the World President, the Principal Vice President shall preside over the General body and discharge his duties.
- 03. On behalf of the World President he shall represent him self.
- 04. He can make world wide contacts

10. GUARDIANS

- 01. The Guardians shall be selected by the General Body Assembly.
- 02. The Guardians are also placed in both executive and central committee
- 03. The Recommendations of the Enforcement Committee should be recognized by the Guardians.
- 04. Whenever Necessary the Guardians streamlined resolutions after consulting with Enforcement Committee, Executive committee and the Central committee also.

11. DEPARTMENT ORGANIZERS

01. The Department organizers who hold the charges till the retirement or unable to provide the service.

- 02. on the recommendations of the Department organizers, the General body appoints Advisory Committees which the committee shall precede with out time limitation. All the activities of the committee shall be supervised By the Department Organizers.
- 03. All the contact of the committee may be viewed by General Body through The Department Organizers.
- 04. The General Body can eliminate any one from the committee when ever necessary.

12. GENERAL BODY

- 01. The General Body Consists of the President in the Head Quarters, Secretary, Financial Secretary, President of the branch, Organizers at union level and also Guardians.
- 02. The General body assembles once in a year and also announce the meetings will be conducted in which country in the next year.
- 03. Urgent/Emeregency General body meetings may be conducted on prior communication of before 14 days.
- 04. The General Body also recognizes to independent empowers to the World President and the World Secretary on the basis of essential circumstances.
- 05. The General body never interfere the controversiality approach between The Head Quarters and the Branches the matters can be referred to the Enforcement committee.
- 06. The Guardians and the Enforcement Committee also monitor the General Body Election.

(13) UNION-ORGANIZERS

- 01. The Union Organizers shall be elected in once in a three year
- 02. The Union Consists of Union Europe, Union of America, Union of Asia, 3 Union of Scandinavian, Union of African and Union of Australia also.
- $03. \quad The \, Union \, Organizer \, also \, monitors \, the \, functions \, of \, the \, branches.$
- 04. The Union Organizer appoints the president of the Branches, with the approval of the World President.
- 05. The Union Organizer increases more branches with his jurisdiction.

06. The Six Union Organizers may jointly act as Presidents and Members Of the Enforcement committee.

14. ENFORCEMENT COMMITTEE

- 01. This committee also becomes forum of the Justice
- 02. Anonymous, this committee shall be selected by the General Body.
- 03. This committee has been empowered to conduct any organizer in order to unfair proceedings
- 04. The World President, world Secretary, and the union organizer can Take action against any body through the Executive Committee.
- 05. Above said action can be announced through the Guardian of the organization.
- 06. The General Body can only take action against the Enforcement Committee Organizer can not take any action against the committee except the General Body
- 07. The Rules and regulations are common to the Committee regarding appointments.
- 08. The Head-Quarters can provide financial assistance for the expenses Of the committee.
- 09. The members of Enforcement committee are also placed as member of the General Body.

15. Advisory Committee

01. The committee consists of seven members may be constituted by the Administration especially to provide consultation for development of the organization. The members are honorary members of the organization. They have no right of votes.

16. ENDOWNMENT FUND

The annual Subscription of the members can be determined on basis of value money of the respective country

17. MEMBERSHIP-DIPLOMA

Membership-Diploma will be given to the Life Members who are working above five years as in the World Tamil Cultural Organization

18. DEPARTMENTAL RESPONSIBILITIES

- 01. Tamil Education, Fine Art Development Department,
- 02. Department of Media,
- 03. Membership-right with UNSCO United Nations Organization,
- 04. Committee for Tamil World Awards,
- 05. Tamil Heritage Month Regulatory Committee,
- 06. Follow Prayer and Ritual Procedure through the Tamil Language &Encouraging the same
- 07. Refresh & Encouraging Tamil traditional Sports,
- 08. Organizing Conference & Research to develop the Tamil Language and cultural activities including monuments.
- 09. Cordially relationship with the Government of Tamilnadu, North Regional Tamil Government in Srilanka the Local Bodies and other countries Which are being governed by the Tamil Representatives in the repatriated countries.
- 10. To Establish Centralization Committee of the organization and also regulating it.
- 11. To Establish World Tamilar Fund, world Bank for Tamilians.
- 12. Whenever Necessary, the addition and deletion in rules and regulations may be made in order to majority of the General Body.

19. ORGANIZER, DEPARTMENT OF LAW

- 01. He is a responsible person to law department
- 02. Whenever arising legal problems or disputes, he can give advice to set aside and enforcing the same.
- 03. Regarding organizational rule and regulation, Advices can be obtain from him as essential one.

20. CO-ORDINATOR OF THE BRANCHES

01. He establish branches in Tamil people are residing in the particular area of the country and also linked with the World Tamil Cultural Organization.

- 02. He also becomes Coordinator of the Central Executive Committee.
- 03. He also regulates the World Tamil Cultural Organization, and the branches and also make cordial relation with the other Tamil Organization with integrality all the functions of above said the organizations.

21. BOARD OF EXECUTIVE DIRECTORS

01. The Board consists of 11 members.

22. CENTRAL COMMITTEE

The Committee consists of Members of the Executive Committee, Representatives of the branches of the countries.

23. GENERAL ASSEMBLY

01. The Members of the world wide of the World Tamil Cultural Organization are also placed on it.
